This voucher is non-refundable, non-transferable, and is valid for the next season.</p> <p>For all other reasons:</p> <ul style="list-style-type: none"> -Cancellation up to 30 days before the start of the stay, the deposit of 30% of the amount of the stay will be retained by the campsite as cancellation costs. -Cancellation less than 30 days before the start of the stay, the deposit of 30% of the amount of the stay will be retained by the campsite as cancellation costs.
